

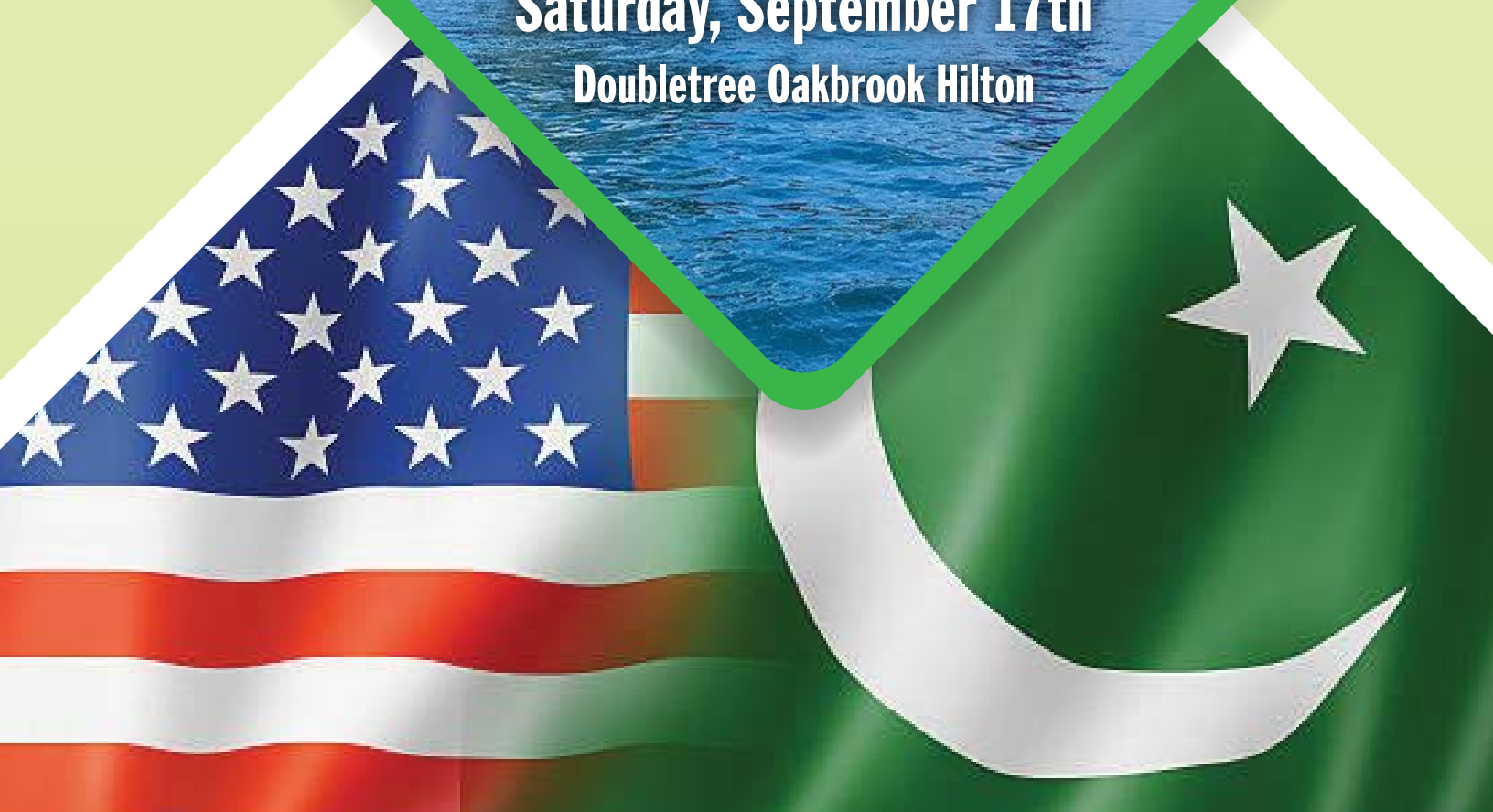

Message of President PPS Dr. Asif Syed

Welcome to PPS's Annual Meeting 2022

I am extremely humbled and honored to serve as your President for 2022. I thank each one of you for supporting your very own society throughout the year, which is also the testimony of your faith that you entrusted on me in 2020 and my commitment to the organization.

As I promised in January when I took reins of PPS that with my councils', memberships and community's support PPS will make meaningful contributions to the local community, back home in Pakistan, and beyond to make a lasting impact. We will build collaborative relationships with institutions locally, in Pakistan, and beyond. So, as promised we just not continued the spirit of community engagement but expanded its role beyond borders to support all communities.

What we have achieved in 2022 is a true example of teamwork to take your vision to greater heights. I thank great mentorship and help of our leaders and respectful society members who helped me in continuing focus on our mission of mentoring, education, healthcare advocacy, service, and charity and made possible to make a lasting, profound impact on the lives of others.

As one of my key goals for 2022, we have accomplished a lot in strengthening the PPS and to make it a grassroots-level organization facilitating healthcare services, community services, outreach, policymaking, advocacy, and legislation in the USA and in Pakistan.

We have forged new relationships for collaboration among healthcare organizations, educational institutions, regulatory authorities, and civic organizations.

PPS has provided a food/pantry donation of \$10,000 during the holy month of Ramzan along with a recent donation of \$15000 to support Pakistan flood relief efforts We are continuing to raise funds and request all of you today to contribute to help our families in need in Pakistan. From clinical services side, our clinic is expanding with more volunteer MDs involved and plans are underway to increase services by hiring a Nurse practitioner. We are also working on establishing an endoscopy suit at Jinnah Hospital, Karachi which will provide diagnostic and therapeutic services to in-need population of Sindh and Baluchistan.

As promised, we also supported advancement of tourism in Pakistan and a group of PPS members and families visited northern areas of Pakistan including Naran, Kaghan, Gilgit, Hunza, Nagar, Skardu and Islamabad in August.

Our website committee worked very hard and focused on making strong digital footprint of our web content with quick upload of news and website upgrade.

As I have mentioned above, advocacy efforts to broaden access to care, capacity building and placement of talent is also a key aspect of my policy and plans for the year. We continued providing clinical rotations, housing, and training to medical graduates from Pakistan. We are also working on providing alternate pathways to physicians who are unable to get a residency slot. PPS in collaboration with the Chicago Medical Society is a part of the Governor of Illinois task force which facilitated the process of authorizing international medical graduates to work under supervision in Illinois as a part of proclamation within Governor Pritzker's COVID-19 medical relief act. We are currently working with Illinois house, senate, and other state regulators to make it a more permanent licensing option for these trained graduates. We are also working with the federal and provincial governments in Pakistan to work out a permanent solution to get Pakistani institutions accredited by World Federation for Medical Education (WFME) and avoid a major issue for our medical graduates. Recently, I led a group of PPS members to meet former PM Imran Khan, Foreign office dignitaries at MOFA, DG health, Director PIMS, CEO AKU and Health Minister Sindh to advocate for their support in this major policy issue. I also met Ambassador Masood Khan in Chicago to garner his support and continue pleading our case with the US officials.

One of our main assets, PPS house has been brought back into a reasonably usable condition with top 2 units recently rented generating revenue whereas the bottom two units are being dedicated to students' residence and currently being utilized by them on continuous basis.

I am highly indebted to my officers, council, BOT, members, alliance, meeting chair & co-chair and the community for their overwhelming support to make this year and the meeting a success.

Lastly, I would like to thank our very own, Consulate General of Pakistan, Chicago, Hon' Tariq Karim for his unwavering support and dedication to the PPS.




Hello PPS members, council members, board of trustees, dignitaries, and friends:

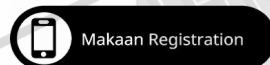

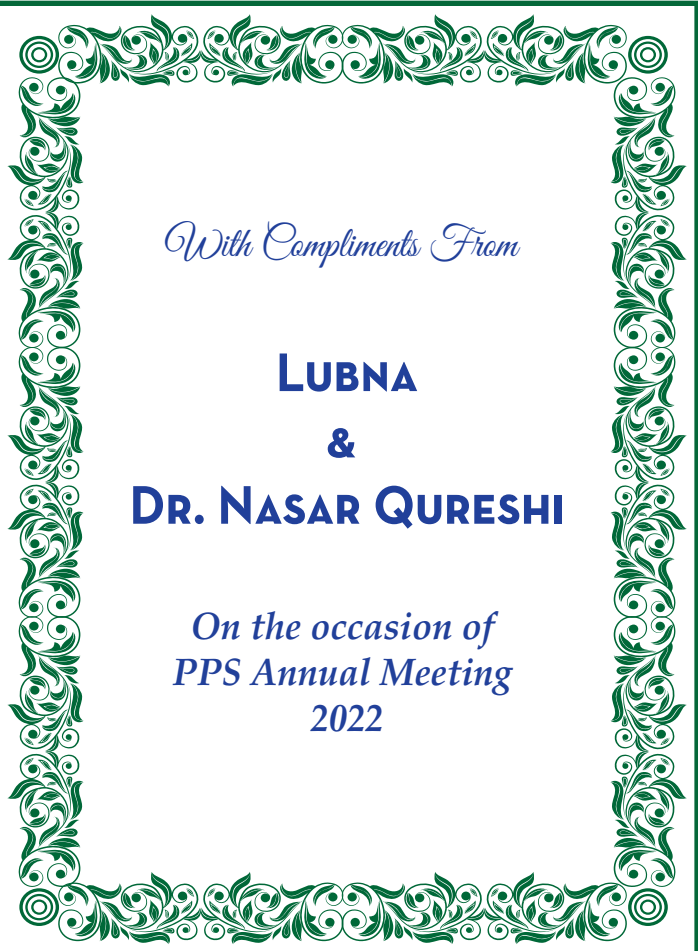

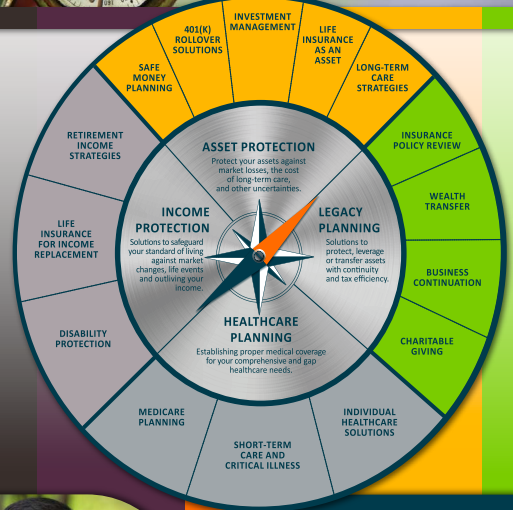
